Structure, Governance and Management

The Group's governing documents are those of the Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of the Scout Association.

The Group is a trust established under its rules which are common to all Scouts.

The Trustees are appointed in accordance with the Policy, Organisation and Rules of the Scout Association.



The Group is managed by the Group Executive Committee, the members of which are the "Charity Trustees" of the Scout Group which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Committee consists of 3 independent representatives, Chair, Treasurer and Secretary together with the Group Scout Leader, individual Section Leaders and parent's representation. The Committee meets approximately every three months, with additional meetings as required. This Group Executive Committee exists to support the Group Scout Leader in meeting the responsibilities of the appointments and is responsible for:

- The maintenance of Group property;
- The raising of funds and administration the Group finance;
- The insurance of persons, property and equipment;
- Group public occasions;
- Assisting in the recruitment of leaders and other adult support;
- Appointing any sub committees that may be required;
- Appointing Group Administrators and Advisors other than those who are elected.

Risk and Internal Control

The Group Executive Committee has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

- Damage to property and equipment. The Group would request the use of property and equipment from neighbouring organisations such as the Penketh Methodist Church and other Scout Groups. Similar reciprocal arrangements exist with these organisations. The Group has sufficient insurance in place to mitigate against permanent loss.
- Injury to leaders, helpers' supporters and members. The Group through the capitations fees contributes to the Scout Associations national accident insurance policy. Risk Assessments are undertaken before all activities.
- Reduced income from fund raising. The Group is primarily reliant upon income from subscriptions and fundraising. The Committee could raise the value of subscriptions to increase the income to the Group on an ongoing basis, either temporarily or permanently.
- Reduction or loss of leaders. The Group is totally reliant upon volunteers to run and administer the activities of the Group. If there was a reduction in the number of leaders to an unacceptable level in a particular section or the Group as a whole then there would have to be a contraction, consolidation or closure of a section. In the worst case scenario the closure of the Group.

The Group has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss; these include 2 signatories for all payments and comprehensive insurance policies to ensure that insurable risks are covered.

Objectives and Activities

The objectives of the Group are as a unit of the Scout Association. The aim of the Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potentials, as individuals, as responsible citizens and as members of their local national and international communities. The method of achieving the Aim of the Association is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership.

Achievement and Performance

We began the year with 79 young people, supported by 29 adult leaders and Executive Members. By the end of the year the number of young people had risen to 87 whilst the number of adults had decreased to 20. This reduction in adult numbers affects both leader and executive roles with some adults taking on different roles. A recruitment plan has been drawn up to address the vacancies, prioritising on Beaver leaders and a Group Chairperson.

The Covid-19 epidemic has had a significant impact on the scope and method of programme delivery. The start of the national lockdown meant that all face-to-face activities had to stop and it remained the case for the rest of the year. Amounts paid to the group in respect of cancelled activities were refunded as appropriate in year. The group purchased Zoom to allow virtual meetings to take place for fortnightly section meetings. Uptake of the offerings was around 50% with those attending enjoying the activities that were taking place.

Beavers were unable to meet for much of 2020. The leadership team was already light in numbers and personal commitments forced the leader to take a break from Scouting. Towards the end of the year a leader from a neighbouring group opened-up their sessions to our members. 167 badges have been awarded with one Chief Scouts Bronze award.

Cub activities were suspended until Autumn when they resumed their activities through online meetings. 282 badges have been awarded.

Scouts ran virtual meetings from the start of lockdown and throughout the year. Although their planned international camp to Germany had to be cancelled, their monthly Zodiac camping challenge continued to take place either in their own garden or in makeshift dens in the house.

A successful plant sale in late spring raised the Group's profile in the community and provided a welcome source of income, allowing the Group to make a donations to a homeless charity (Room At The Inn) and a family support group (St Josephs' Family Centre).

In line with the rest of society, the Group has faced a challenging year, with much of its normal activities unable to take place. Good management over several years and the ongoing voluntary subscriptions means that the group is financially well-positioned. The remaining adults are committed to restoring the Group to full strength and returning to a normal Scouting life when current restrictions allow.
